


Introduction

Service Description



Services Provided:


- Browse the content of the product and service catalog.

- Subscribe to products and services and obtain access keys.
- Review and pay invoices through the SADAD payment system.

Work Rules

1. The user must register on Etimad platform to benefit from the Developer Portal.
2. The user must activate the required permissions to access the portal.
3. The user must agree to the terms and conditions of the Developer Portal.

User Guidelines

Step 1: Explore Our Products

Visit the Developer Portal at apiportal.etimad.sa and explore the list of available products and services before you start developing your own application and benefiting from the services.

Step 2: Log in to Your Account

Log in to your Etimad account according to the entity you belong to (government entities, business sectors) to be able to start developing your first application.

Step 3: Create Your First Application

Create your own applications in the Developer Portal and link them to the products to begin using the production environment.

Submit a request to subscribe to one of the products, and after your subscription request is approved, you can follow these steps to create your application:

- Log in to your account.
- Click on the User Profile tab, then go to Applications.
- Click on "Add Application +".
- Enter the application name and description.
- Choose the product you want to use.
- Click OK to complete the application registration.

You can now obtain your application information, including the application key and secret key. These keys are required for access.
