



Introduction


A service that aims to enable registered developers to manage their applications, by adding a new application from the list of subscribed products, with the option to enable, disable or modify any of them.

Services provided:


- Browse the content of the catalog of products and services.

- View and pay bills through SADAD.


Business Rules

Service Workflow






Step One: Explore the products

and explore the list of available products and services before you start creating your own application and benefiting from the services.




Step Two: Filter Products




The user can filter the display of products and view the available products or products on trial or view them all by clicking on "All".



In case the user wants to view product details, they can click on the "View Details" button to display a window with the details of the selected product.






Step Four: View the product details page

The user can view the product details and review the product overview with the option to subscribe to the product.





Step Six: Confirm your subscription


After clicking on the subscribe option, a pop-up window will appear to confirm the subscription, the user can click on (Confirm) to confirm the subscription.



Step Seven: Go to the application management page


After subscribing to the product, the user can click on (Manage Applications) at the top to enter the Application Management page.






Step Eight: Add a new application

Step Nine: Add a new application


After entering the (add a new application) page, the user must fill out the form that appears, which includes the following information:

Step Nine Continued: Add a new application


After choosing the type of use, you must enter the application name and the technical name of the application.

The technical name of the application: It must include only Lowercase English characters without special characters, or spaces.




After selecting the product, you can click on the (Add) button and a pop-up window will appear to confirm the addition of the application.



After confirming the addition of the application, the user will go to a page that confirms the process of adding the application successfully. The user must click on the Application Management button to view the applications that were previously added.






Step Eleven: Manage Applications

After entering the applications management page, the user can activate or deactivate the applications, and he can also click on the icon to view the details of a specific application.



The page is displayed in English. If the user wishes to view it in Arabic, they can click on the (Arabic) button at the top of the page to change the language.




